# Virginia Medicaid is taking action to fight COVID-19



No co-pays for any Medicaid or FAMIS covered services



No pre-approvals needed and automatic approval extensions for many critical medical services



Outreach to higher risk and older members to review critical needs



90 day supply of many routine prescriptions



Ensuring members do not inadvertently lose coverage due to lapses in paperwork or a change in circumstances



Encouraging use of telehealth

Medicaid covers all COVID-19 testing and treatment. Call your doctor.



# Medicaid Eligibility Safeguards

During the Emergency
No one will lose their Medicaid Health Insurance
No one will lose their Medicaid Waiver
-Even if you don't use Waiver services-



# **Medicaid and Medicaid Waiver Programs**

- Personal Protective Equipment is not covered by Medicaid
- Authorizations for Consumer Directed Services\* extended by 2 months. \*Personal Care \*Respite \*Companion
- You may apply for Waivers
- Increasing and Adding Services



#### **Electronic Visit Verification**

The EVV system is in effect.

Attendants and EORs should call their fiscal agent if they have trouble with the EVV system

DMAS is paying attendants even if the attendant time entries or approval by the EOR are not EVV compliant.



# Early Intervention - Birth to 3 years

#### Services are available

Ongoing developmental services, physical therapy, occupational therapy, speech/language, monitoring of successful program and instructional Implementation and service plan development.

**Assessments** for new children in person or telehealth

May use Telehealth or Remote Care Delivery



# **Recovery Rebate Checks**

One time tax rebate for adults

Amount depends on your income

\$1,200 for adults, income less than \$75,000

\$500 additional amount for each child

Does not affect public benefits

SSI recipients may need to file 2019 tax return



#### **Unemployment Benefits**

**Unemployment Benefits have been increased** 

Consumer Directed employees/attendants are eligible to apply.

If you lose employment or have a reduction in hours

#### My Job and Services

#### What do I do if my job tells me I can not work through this emergency?

Call your your Case Manager/Support Coordinator and if you have a job coach call them Call the agency that provides your other waiver services for assistance or your Care Coordinator. You may be eligible for unemployment benefits from the Virginia Employment Commission.

#### What do I do if my waiver support staff doesn't show or are not able to come work with me?

Call the agency that provides your services and let them know.

**Call your DD Case Manager/Support Coordinator** 

Call your Services Facilitator if you have consumer-directed services

Call your Care Coordinator with your managed care plan.



## Will There Be Changes to the Waivers?

#### Allowances that are being considered, not currently approved:

- Parents of children providing attendant care
- Increased hours for attendants who do not live in the individual's home
- Increase of Respite hours from the current 480 hours annually.
- Expedited approval of new attendants
- Expedited processes for new Employer of Record applicants.

Please note the above allowances are under consideration as well as others. When further information is known we will update our website.

#### Not required to have in-person meetings for:

Annual Individual Services Plan

**VIDES** 

Supports Intensity Scale (SIS)

Completed by telephone or telehealth
